**RE:** **Visual Changes Expected at *Devil's Tea Table* Rockface, Kingwood Township, NJ**

- RT 29 NJDOT Mitigation Project (Milepost Route 27.31 to 30.43)
- Public Meeting: August 1, 2019 in Kingwood Township, NJ (Kingwood Township Committee)

The National Wild and Scenic Rivers System was created by Congress in 1968 (Public Law 90-542; 16 U.S.C. 1271 et seq.) to preserve certain rivers with outstanding natural, cultural, and recreational values in a free-flowing condition for the enjoyment of present and future generations. The Lower Delaware Wild & Scenic River Management Council\* (LDW&SRMC), a part of the National Wild and Scenic Rivers System, focuses on the area of the Delaware River south of the Delaware Water Gap and north of Trenton.

The LDW&SRMC Management Plan requires the evaluation of projects that may impact the “remarkable scenic views and vistas” along the River (<https://lowerdelawarewildandscenic.org/index.php/resources/documents/lower-delaware-wild-and-scenic-management-plan>). As such, we are writing to advise that the New Jersey Department of Transportation (NJDOT) is planning a mitigation project in the *Devil's Tea Table* area along Route 29 in Kingwood Township, New Jersey. While this project is designed to improve public safety by remediating the rockface and installing rockfall control measures, this area is within the Lower Delaware Wild & Scenic River corridor and provides “remarkable scenic values.” The area also parallels the Delaware River Scenic Byway, a designation by the USDOT, endorsed by the NJDOT, and subject to the Delaware River Corridor Management Plan (<https://www.state.nj.us/transportation/community/scenic/pdf/drsbcmp.pdf>.)

When complete, the mitigation will radically change the visual nature of the area, directly affecting Tinicum Township views across the river and those traveling along River Road in Bucks County, Pennsylvania and along Route 29 in Hunterdon County, New Jersey. The nature of the mitigation could include the removal of trees/vegetation from *Devil's Tea Table*, rock removal or reinforcement, mesh or "draping" material installation, and the creation of a new barrier or a "catchment ditch." Anyone concerned about the construction and permanent aesthetics, may attend the **Thursday, August 1, 2019 meeting of the Kingwood Township Committee to hear about the project from NJDOT officials, pose questions, or make public comment.** The meeting will be held at 7:00 PM at the Kingwood Township Municipal Building located at 599 Oak Grove Road, Frenchtown, NJ, 08825 in the upstairs meeting room. The presentation is scheduled as the first agenda item.

Public feedback regarding the nature of the mitigation and the design of the improvements/materials are encouraged. For instance, the report mentions color-coded draping material and vegetative cover. Residents living on Bridge Four Lane and Bridge Five Lane in Tinicum Township, PA, or anyone driving, hiking, or biking on either side of the river, will see a different rockface after the mitigation project is complete. Municipalities and/or counties are strongly encouraged to notice property owners who could be impacted by the project.
