- Sarah-Going to finalize the budget and submit it for the cooperative agreement. \$210,000 split between HTL and DRG.
- Richard-Created 3x5 card with LDWS info. QR code for the website.

- Cindy-We've been narrowing the list to high-impact items. Mostly centered on:
  - i. Safety
  - ii. Water Quality

- Lauren-went on Tuesday. Started at Worthington and finished by Belvidere, 94 people. Great experience.
- Sarah-first year was impressed with how smooth running it was and the positive vibe from participants. Very safe, Canoe Safety Patrol did an excellent job.



- Richard-noted their ability to adjust quickly due to weather. Rained Thursday morning and paddled when it cleared up in the afternoon.

## 6. Delaware River Tributaries and new designations

- Working to get additional tributaries designated.
- Sarah-the work can preempt any industrial projects that may threaten in the future.
- Tributaries that have associations would be the easiest to move along.

## 8. Ongoing Matters (30 Minutes) –

- Rockfall Mitigation Projects - Tara Mezzanotte
  - Tara-Appear to be on hold but it is not on hold. Not scheduled for construction until 2025, all behind-scenes work is going on. Public and stakeholders need to continue doing work.
    - Archeological studies and field study-report will be out in the fall.
    - Pushing for an environmental impact statement.
    - New project in S curve base of Mt. Tammany, replace retaining wall along I-80, which is in a state of disrepair. Construction 2025.
    - 6 Years \$120 million dollars.
  - Adam-Lenape Nation of PA is requesting environmental studies for rockfall. Involved PA and NJ mayors and wrote formal letters.
  - NPS has been commenting and has an internal coalition working on it.
- September 11<sup>th</sup> National Memorial Trail Paulinskill Trail/Knowlton to the Gap - Tara Mezzanotte
  - Connects World Trade Center, Pentagon, and Flight 93 national memorials. Travels 10 miles along the river. Not complete yet.
- Warehouse projects – Judy Henkel
  - Sarah-NPS Compliance department who leads when a project affects several parts of NPS. Mark Eberle is taking the lead and sent a letter to set up a way to comment in the future.
  - The LVPC has accepted for review a sketch plan associated with the River Pointe Logistics project located in Upper Mount Bethel Township. The sketch plan conceptualizes 12 industrial buildings totaling 5,873,000 square feet on approximately 804 acres of land. The site is located on River Road, bounded by River Road to the northeast, Pine Tree Lane to the southeast, and Potomac Street to the southwest, approximately 600 feet southwest of the Township border with Portland Borough.
  - Judy-group suing the supervisors and developer got in. Lawsuits were settled.
    - Portland Powerplant is being taken offline, a 126-acre strip along the river. Environmental studies are being done now.
    - 3 different LLCs trying to build warehouses, one developer.
    - Settling pond studies are being done. The old ponds are contaminated with arsenic. EPA in PA allows for partial, building first unit by cleaner ponds and then cleaning up



the rest of the ponds. Cleaning is adding 2 inches of clean soil or cap with a parking lot or building.

- CC-suggested Judy check into the EPA TASC (Technical Assistance for Communities) program. New technology to explore settling ponds. Extra testing can help with stance.
- Trenton Mercer Airport-Expansion has been approved. The expansion will start. We will monitor.
- Delaware River Aqueduct- Was planned for October 2022, closing into the spring of 2023. Now planned for October 1, 2023, through May 31, 2024. These aqueducts pump water into NYC and overflow runs into the Delaware River and need to close for repair.
- Other
  - Adam-Rising Nation River Journey starts July 30<sup>th</sup> to August 20<sup>th</sup>. All environmental organizations are invited to reach out, give a presentation, paddle, and sign the treaty.
  - Adam-push to make Delaware Water Gap a national park
    - Sarah-different funding streams and staffing types. Different protections and priorities at NPA.
      - National Park is a higher level
      - Adam-it's controversial-tourism, overuse, and protection. Put on next meeting's agenda.
      - Sarah-to investigate.
