• Drought continues, DRBC drought information

- Some snow in the upper basin, rain in the lower, and expecting flooding in the main stem.
 Drought declared based on NY reservoir status. Please conserve water.
- New-Hope Lambertville Bridge pedestrian bridge open until <u>January 13</u> and bridge will close on January 13 for <u>two weeks</u>
- Warehouse, River Pointe Logistics Upper Mt. Bethel, \$1.5M granted to clean up former Slate Belt coal plant
 - Judy-coal fields or plants, it could become a plant for a data center. Warehouses are being sold as data centers.
- Hal H. Clark, Boat Launch, Pedestrian Trails Coming To New County Park In <u>Solebury</u>. Construction to begin next year
- Paunnacussing gas line and Aqueduct Sarah
 - PennDot in design for Fleecydale road and which is closed and for the pipeline design in process to get cement covers out of the creek.
- RT 80 Rockfall Mitigation and retaining wall. Warren County got news it's pushed out to 2026 for Rockfall. They need to coordinate with NPS for historical preservation. The location is a little upstream of LDWS. The Supreme Court heard arguments for NEPA up and downstream impacts for environmental review.

There is no material that will be washed away. Addressing the stone wall too.
