1. (10 min) Welcome - Richard Dodds, Chairman – <u>Introductions</u> and Land Acknowledgement

We commit to improving this relationship, supporting Lenape recognition in Pennsylvania and New Jersey, and working together on programs and projects to benefit the Delaware River.

2. (15 min) 2024 Budget Review - Richard

- (Sarah pie chart) SC approved budget for next fiscal year

4. (15) Delaware River Tributaries and new designations presentation— Tara Mezzanote

- Our work so far, thank you Tara, has been more successful than anticipated so have to regroup
- Will be addressed (SC is addressing)
- Study documentation and management plan subject matter expert being engaged
- Tara-Original act did not include Easton and Phillipsburg. The study did not allow for industrialized areas. The change is that these areas can be studied for designation. Northampton County supports.
- Alison-Easton and Phillipsburg, the view is now seen as more for beauty than industrial history.

6. (30 min) Ongoing Matters - Richard and all

- Warehouses
 - o Richard-Jaindl site will be permanently preserved agricultural lands.
 - RPL Mt. Bethel, supervisors grant preliminary approval. PA DEP November permit meeting. LDWS submitted comments. Supervisors disband sewer authority.
 - 1. Tara-change in supervisors, less in favor of the development. Now the municipality has an EAC in Upper Mt. Bethel first meeting in April. Judy-undoing preliminary approvals is tough. If wastewater treatment goes in, it will go underground and go to spray irrigation in an R1 zone in a different watershed. The Demi Road project has been stopped up until now.
- Paunnacussing gas line and Aqueduct
 Sarah
 - o Very flashy, suffering erosion. Repair work on the canal aqueduct at the base of the creek. Working with the town and gas company for long lasting repairs to cover the line (line is not broken).
 - o Fleecydale Road-early stages with PennDOT on repairs to the closed road.
 - o NPS provided contractual consultation regarding the creek.
 - o Richard mentioned that NPS offers this kind of support as a benefit to joining LDWS.
 - o Tony asked if there is communication between LDWS and Musconetcong Watershed Association especially regarding septic water getting into the Musconetcong. Sarah-LDWS has tried to get a council to council conversation going with the Musky in the past. Asked Tony to connect us with the Holland Musky rep.
- Rockfall mitigation Stephen, Richard, Tara
 - Devil's Tea Table
 - 1. Bucks County Article
 - 2. Change the safety bar-NPS to meet with FHWA to see if this can be required by FHWA as a condition of federal funding.
 - Options such as just monitoring the road, changing the speed limit on the road and expanding the ditch were written off for reasons that there is nowhere to station a police car, the expanded ditch does solve the problem, and just monitoring is not considered an option.
 - 4. NJDOT offered up a lower impact option that they still need to investigate involving moving the road, but they stated that this might have other impacts on the canal towpath and other natural resources (trees). This is more impactful to other resources because they are refusing to lower the 95% criteria. If they lower to 90%, it will likely be less impactful on other resources.
 - 5. Stephen-Rt 29 mitigation projects the Kingwood design workgroup NJDOT started and are awaiting the 5th meeting. They are

- supposed to respond to our request for concessions of a less invasive mitigation. Feeling a stalemate. Start date pushed back to 2029. A Stephen and a small group met with Gov. Murphy regarding the project.
- 6. Sarah-hopes NPS agency to agency meeting to push safety rating and lower impact project, and hopes they are taking time to work on that. Might be too optimistic.
- Work Group being established by NJDOT for Route 29/Goat Hill section (Lambertville/West Amwell)
 - 1. Anyone signed up for Work Group?
- The <u>Landing in New Hope</u>- NPS received plans. Update: Michele B.-Landing withdrew the plans from zoning.
- o Sarah-Making separate meeting to discuss section 7.
- New business Other issues?
 - Lois-William's Township joined LDWS with Fry's run. Proposal for campground. Requested LDWS send letter. Richard-We'd love to know more about it. Robert-Been in touch with Fry's Run, local zoning issue.
